**SUPPLEMENTAL ORDER RELATING TO CRIMINAL DISTRICT COURT
OPERATIONS DURING COVID-19 PANDEMIC**

On March 19, 2020, The Supreme Court of Texas (No. 20-9044) and The Court of Criminal Appeals (No. 20-008) issued the Third Emergency Order Regarding the COVID-19 State of Disaster, "prohibiting non-essential proceedings in person contrary to local, state, or national directives..." In order to comply with the order this Court hereby establishes the following presiding schedule, effective Monday, March 23, 2020.

All regularly scheduled dockets in all criminal district courts are hereby suspended through May 8th.

Only proceedings deemed by the presiding criminal district court judge to be essential will be heard.

All essential proceedings throughout all of the criminal district courts in Bexar County shall be referred for placement on the docket of the presiding criminal district court.

Preference will be given to those essential proceedings that may result in the release of an inmate from the Bexar County Adult Detention Center.

County Magistrates are also available to hear criminal matters and to sign warrants. The County Magistrates' office can be reached by contacting the clerks at 210-335-6112 or 210-335-6113.

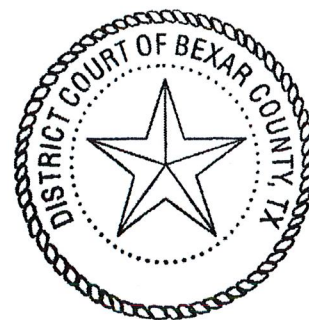
